With reference to your application dated 2022 and subsequent correspondence with the school or inspection in this regard, I convey that the Bharatiya Vidya Bhavan Residential Public School, Vidyashram, Bhimavaram, West Godavari as recognition for Middle school, Secondary and Senior secondary classes since 1984. With reference to NOC dated 31st October 1984

1. The school shall abide by the provisions of Right of Children to free and compulsory education act 2009(Annexure I) and the right of children to free and compulsory education rules 2009(Annexure II).
2. The school shall admit in class 1 to the extent of the _ of the strength of the class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory Elementary Education till its completion. Provided further that in case of pre primary classes also this norm shall be followed.
3. For the children referred to in paragraph 2, the school shall be reimbursed as per section 12 of the Act. To receive such reimbursement schools shall provide a separate bank account.
4. The society/school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
5. The school shall not deny admission To any child for lack of age proof .
if such admission is sought subsequent to the extent of provider prescribed for admission on the grounds of religion, caste or race, place of birth or any of .

6. The school shall ensure:

- i). No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - ii). No child shall be subjected to physical punishment or mental harassment.
 - iii). No child is required to pass any board examination till the completion of elementary education.
 - iv). Inclusion of students with disabilities or special need as per the provision of the act.
 - v). The teachers are recruited with minimum qualification as laid under Section 23(1) of the Act provided further that the current teachers who at the commencement of this act do not possess minimum qualification shall acquire such minimum qualification within a period of five years.
 - vi). The teacher performs its duties specified under Section 24(1) of the Act and
 - vii). the teacher shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
 8. The school shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the act.

9. The school shall maintain the standards and norms of the school as specified in Section 19 of the act. The facilities reported at the time of last inspection are as given below, given under

12. The school is run by society registered under the societies Registration Act 1860(21 of 1860),or a public trust constituted under any law for the time being enforce.
13. The school is not run for profit to any individual group or association of individuals or any other persons.
14. The account should be audited, certified by the Chartered Accountant and proper account statement should be prepared as per rules. A copy each of the statement of account should be sent to the DEO every year.
